The undersigned does hereby discharge, release and hold harmless, **Wilton Manors Art and Entertainment Expo**, hereby referred to as **WMAAEE**, which includes Wilton Manors Entertainment Group Inc, in partnership with the City of Wilton Manors and Art Gallery 21 Inc, property owners, and associations, and all co-sponsors from any and all manner of action, suits, damages, or claims whatsoever arising from any loss or damages or claims, to the person or property of the undersigned while in possession or under the supervision of the sponsors during the WMAAEE and hereby consents to enforcements of all rules of the WMAAEE in Wilton Manors. Furthermore, the undersigned artisan hereby certifies that all displayed work is handcrafted and created by the seller, or displayed with permission from the artisan (i.e. authorized gallery or artist representative). Participant understands that any mass-produced item on display can cause expulsion from the show. In case of a hard rain, the expo will be moved to the Hagen Park Auditorium.

**WMAAEE RESERVES THE RIGHT TO DISQUALIFY ANY EXHIBITOR CAUSING ANY PROBLEMS TO FELLOW EXHIBITORS OR MANAGEMENT.** Failure to comply with the rules and regulations set forth on this General Release may result in expulsion from any and or all activities. WMAAEE reserves the right to make final interpretation of all rules. WMAAEE has my permission to reproduce my artwork, through photographs I have submitted, for the purpose of advertising and marketing. WMAAEE also has my permission to publish photographs or videos taken of me, my display and my artwork during the WMAAEE Art Walk for purposes related to promotion of the WMAAEE Art Walk, past or future. The possible photographs would not be for sale. WMAAEE is not responsible for the loss or damage to the exhibitor's property. All exhibiting artists are responsible for their own property in the event of loss, damage or personal injury. WMAAEE, or its affiliates/sponsors will not assume liability for any act of God, natural disaster, exposure to adverse weather conditions, damages, injuries or any legal authority, or any cause above and beyond the control of WMAAEE. WMAAEE is not a flea market. All works of art exhibited must be for sale. All work must be original, handcrafted and created. Artwork must be exhibited by the artist, authorized artist representative or representative gallery. Kits, imports and mass produced items will not be accepted. This rule will be strictly enforced to insure the integrity of the WMAAEE. I will pick up my artwork at the time agreed upon by me or my representative and the sponsor business. I realize that by not complying with this agreement the sponsoring business reserves the right to: 1) Charge for storage for the left-behind artwork, or, 2) Discard the artwork after 15 days, or 3) Use artwork for auctions or fundraising events. In signing this form I agree to hold harmless WMAAEE from and against any claim or issue arising from my continued business relationship with any sponsor business of the WMAAEE. Arrangements between myself and/or my representatives with the sponsoring business is solely my responsibility. I hold harmless WMAAEE, for any extenuating business agreements or circumstances. WMAAEE is a private enterprise, a grassroots effort between WMAAEE and the sponsoring businesses and the general public is invited. I agree that my publicly displayed artwork will be in compliance with the laws of the land, whether City, County, State or Federal. I understand that I understand if any pornographic artwork or artwork of a graphic sexual nature is displayed, it must be sectioned off and prohibited to persons under the age of 18, with the proper signage. I also understand that WMAAEE and its business sponsors reserve the right to deny any artist, for any reason. There is a \$50 deposit placeholder fee to the Artist to participate in the WMAAEE. This fee will be refunded after a the artist's participation. There are advertising opportunities on our WMAAEE website ([www.WMAE.ORG](http://www.WMAE.ORG)). This contract shall be deemed to have been made in the State of Florida and shall be interpreted in accordance with the laws of the State of Florida. All legal action to enforce this agreement shall be brought into the courts of Broward County, Florida, and the exhibitor agrees to the jurisdiction of the courts.
